13. To report the bill dated 18-06-2022 amounting to Rs.94,600/- received from the Advocate, M/s. Girindra Kumar Pathak appointed by the College for attending the hearings for the Case No. CSNo.-4777/2018 titled as Abhinav Jain vs Vinay Jain & Othrs at Distirctt Court, Ludhiana (Punjab). As per the bill received, the Advocate has charged the fees of Rs.5,000/- per hearing + 10% Clerkage to attend the 17 out station hearings at the District Court Ludhianan (Punjab).

The Principal informed the Governing Body that the College has received a bill dated 18-06-2022 amounting to Rs.94,600/- from the Advocate, Mr. Girindra Kumar Pathak appointed by the College for attending the hearings for the Case No. CSNo.-4777/2018 titled as Abhinav Jain vs Vinay Jain & Othrs at Distirctt Court Ludhiana (Punjab). As per the bill received, the Advocate has charged fees of Rs.5,000/- per hearing + 10% Clerkage to attend the total number of 17 out station hearings at the District Court, Ludhiana (Punjab).

The Principal further informed the Governing Body that as per the schedule of fees for the legal work of the University/Colleges, the fees for attending the hearing before the local District Court is Rs.800/- per hearing but the fees, for attending the hearing out of station, is not mentioned in the said schedule of fees by the University. Therefore, a letter No.SBSC/546 dated 29-08-2022 was sent to the Joint Registrar (Legal), University of Delhi seeking clarification about the fees to be paid to the advocate, Mr. Girindra Pathak for attending the out station hearings.

The Principal further informed the Governing Body that in reponse the College letter dated 29-08-2022, the Assistant Registrar (Legal), University of Delhi informed the College that there is no fee mention in the schedule of fees of the University of Delhi for attending the hearing of outstation cases. The bills may be processed by the College itself with the decision and approval of the Governing Body.

After discussing the matter in detail, the Governing ratified and approved to release the payment of Rs. Rs.94,600/- to the Advocate, M/s. Girindra Kumar Pathak against his bill dated 18-06-2022 received by the College for attending the 17 out station hearings at Distrect Court, Ludhiana (Punjab). for the Case No. CSNo.-4777/2018 titled as Abhinav Jain vs Vinay Jain & Othrs.

14. To ratify and confirm the approval of the Chairman, Governing Body dated 21-03-2023 regarding grant of Extra Ordinary Leave (without pay) with lien initially for a period of one year w.e.f. 13-04-2023(F/N) to Mr. Vivek Rangan, working as Jr. Asst, in the College to join as Upper Division Clerk in National Consumer Disputes Redressal Commission, Delhi.

The Principal informed the Governing Body that the services of Mr. Vivek Rangan as Junior Assistant were confirmed on 19-06-2019 in the College. Mr. Vivek applied for the post of UDC in NCDRC after joining the duties in the College and informed the College by his letter dated 20-07-2023 and the Competent Authority allowed him to apply through proper channel for the said post. As per University Non-Teaching Employees (Terms and Conditions of Service) Rules 2013 – Chapter II (Section II) Para(3) Retention of Lien – the lien of a permanent employee, who applies through proper channel for a post, may be retained in the College for a maximum period of two years or date of confirmation in the new post, whichever is ealier. Accordingly, Mr. Vivek was granted Extra Ordinary Leave (without pay) with lien initially for a period of one year w.e.f. 13-04-2023(F/N).

The Governing Body ratified and confirmed the approval of the Chairman, Governing Body dated 21-03-2023 regarding grant of Extra Ordinary Leave (without pay) with lien initially for a period of one year w.e.f. 13-04-2023(F/N) to Mr. Vivek Rangan, working as Jr. Asst, in the College to join as Upper Division Clerk in National Consumer Disputes Redressal Commission, Delhi.

To ratify and confirm the approval of the Chairman, Governing Body dated 28-04-2023 regarding constitution of Enquiry Committte constituted by the Competent Authority of the College vide notesheet dated 17-04-2023 in response to letter No. CR-VIG/069/B./Comp./2021/6639 dated 11.04.2023 received form the Joint registrar (CR & Vigilance), University of Delhi regarding sending the outcome of the enquiry, set up on the complaint filed by Shri Rohit Kumar with regard to fake admission during the year 2013-2014.

The Principal informed the Governing Body that the College has received a letter No. CR-VIG/069/B./Comp./2021/6446 dated 25.01.2023 received form the Joint registrar (CR & Vigilance), University of Delhi requesting to send the outcome of the enquiry, set up on the complaint filed by Shri Rohit Kumar with regard to fake admission during the year 2013-2014.

The Principal further informed the Governing Body that a One-Man Enquiry Committee headed by Shri Padam Kant Saxena, Formerly Addl. Distt. & Sessions Judge, (Retd.) was constituted to enquire the matter relating to fake admissions during the year 2013-14. The College vide letter No. SBSC/SPA/38 dated 22-02-2019 also requested the Police Station, Malviya Nagar, New Delhi to make necessary arrangements to get the handwriting verified by the forensic experts at their end. The matter could not be examined as no meeting of the said One-Man Committee was held due to pre-occupation of Sh. Padam Kant Saxena. The College has not received any reply from the Police Station, Malviya Nagar New Delhi. The Principal further informed the members that the services of 02 non-teaching employees working on contract basis were discontinued as the then Competent Authority of the College was of the opinion that they were involved in fake admissions during the year 2013-14.

Since the University of Delhi vide his letter dated 11.04.2023 has requested to send the outcome of the enquiry, the Competent Authority of the College has constituted an Enquiry Committee comprising of the following to enquire with regard to fake admission during the year 2013-2014:

2. Dr. D. R. Saklani, Associate Professor, Department of Commerce, Member
3. Mr. Aravind Kumar Verma, Administrative Officer, Member

The Governing Body ratified and confirmed the approval of the Chairman, Governing Body dated 28-04-2023 regarding constitution of aforesaid Enquiry Committee constituted by the Competent Authority of the College vide notesheet dated 17-04-2023 in response to letter No. CR-VIG/069/B./Comp./2021/6639 dated 11.04.2023 received from the Joint registrar (CR & Vigilance), University of Delhi. It was decided that the Committee be requested to conduct the enquiry and submit its report at the earliest so that the outcome of the enquiry with regard to fake admission during the year 2013-2014 could be sent to the University.

16. To ratify and confirm the constitution of Enquiry Committee constituted by the Chairman, Governing Body vide notesheet dated 31-03-2023 to conduct a fair enquiry at preliminary level enquiry in respect of Mr. Jitender, Senior Technical Assistant.

The Principal informed the Governing Body that there are serious allegations against Mr. Jitender working as Senior Technical Assistant (STA) in the College regarding insubordination (not following the lawful directions of senior officer), using dilatory tactics, causing delay in disposal of work assigned to him etc. Therefore, the Chairman, Governing Body vide notesheet dated 31-03-2023 has constituted an Enquiry Committee comprising of the following to conduct a fair enquiry at preliminary level:

3. Mr. Ranu Kumar, Administrative Officer, Maitreyi College, University of Delhi

The Governing Body ratified and confirmed the constitution of Enquiry Committee constituted by the the Chairman, Governing Body vide notesheet dated 31-03-2023 to conduct a fair enquiry at preliminary level in respect of Mr. Jitender, STA. It was decided that the Committee be requested to conduct the enquiry and submit its report at the earliest for further necessary action.

17. To ratify and confirm the approval of the Chairman, Governing Body dated 22-02-2023 approving the recommendations of the Staff Council of the College made at its meeting held on 27-01-2023 regarding Revision of Annual Fee to be charged from the students of all the 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> year students of the College w.e.f. the ensuing Academic Year 2023-24 to provide them better amenities in the College for teaching learning process and for supporting more number of financially weak students as per details given below:

The Governing Body ratified and confirmed the approval of the Chairman, Governing Body dated 22-02-2023 approving the recommendations of the Staff Council of the College made at its meeting held on 27-01-2023 regarding Revision of Annual Fee to be charged from all the students of the College w.e.f. the ensuing Academic Year 2023-24 to provide them better amenities in the College for teaching learning process and for supporting more number of financially weak students.



18. To ratify and approve the creation of new separate fund/account, i.e., 'Income from Unclaimed Caution Deposits' under the Society Account of the College to credit the unclaimed Library Security received from the students of the College amounting to Rs.77,35,200/- as on 31-03-2019 which is lying unclaimed as on 31-03-2022.

The Principal informed the Governing Body that the Audit Team of the Office of the Director General of Audit (Central Expenditure) during the audit of the accounts for the Financial Years 2017-2018 to 2022-2023 revealed that the Library deposits obtained from the students amounting to Rs.77,35,200/- as on 31-03-2019 is lying unclaimed as on 31-03-2022 with the College. The Audit Team suggested that the unclaimed amount could be credited to a separate fund/account to be used for the payment on items which are not categorised or approved expenditure by the UGC but which may be considered necessary by the Governing Body of the College, e.g., ceremonies, extra expenditure on magazine etc. Therefore, a new separate fund/account, i.e., 'Income from Unclaimed Caution Deposits' under the Society Account of the College is required to be opened to credit the unclaimed Library Security received from the students of the College.

The Governing Body ratified and approved to create a new separate fund/account, i.e., 'Income from Unclaimed Caution Deposits' under the Society Account of the College to credit the unclaimed Library Security received from the students of the College amounting to Rs.77,35,200/- as of 31-03-2019 which is lying unclaimed as on 31-03-2022 to be used for the payment on items which are not categorised or approved expenditure by the UGC but which may be considered necessary by the Governing Body of the College, e.g., ceremonies, extra expenditure on magazine etc. The Governing Body also authorised the Principal to use this money for Students Aid Fund and for other student welfare and related activities.

19. To receive, approve and adopt the Audited accounts of the College for the Financial Year 2020-21.

The Governing Body received, approved and adopted the Audited accounts of the College for the Financial Year 2020-21.


